Arlington Elementary No. 1 (007-48-00-100) : Cost include:geothermal well fields, rooftop photo-voltaic array,lighted turf fields. This school is a "net zero" building and will be built on a site with another school that must remain in operation during construction.

Magna Vista High School Renovations Phase 2 (044-02-00-102) : Work is limited to creating 2 classrooms and support spaces from existing space.

Loudoun Valley High School Additions & Renovations (053-68-00-101) : Total building area square footage is composed of 18,546 SF for renovations and 24,327 for new additions

Park View High School Renovations (053-06-00-103) : Project involves adding a one-story drama classroom addition only

Middlesex High School Athletic Complex (059-09-00-101) : Cost includes athletic fields and support buildings.

New Auburn Middle School (060-65-00-102) : This is a PPEA project, and site cost are low due to the reuse of an existing site.

Twelfth High School (075-109-00-100) : The building cost includes a indoor swimming pool.

Backcreek Elementary School Entrance Modification (080-42-00-101) : Cost for new school entrace only.

W.E. Cundiff Elementary School Entrance Modification (080-06-00-101) : Cost for new school entrance only.

Hidden Valley Middle School Entrance Modification (080-01-00-101) : Cost for new school entrance only.

Northside Middle School Entrance Modification (080-64-00-101) : Cost for new school entrance only

William Byrd Middle School (080-23-02-101) : Cost for new school entrance only.

Glenvar Middle School Entrance Modification (080-61-01-101) : Cost for new school entrance only.

Stafford High School Replacement (089-02-00-100) : Other site cost include \$454,000 for demolition of existing building. Other Building cost include \$1,660,000 for lockers and utilities.

Jefferson-Houston PK-8 Combined School (101-09-01-100) : Project cost includes demolition of existing school structure, new underground cisterns for gray water system and extensive site and storm water management system.

New Huguenot High School (123-151-00-100) : Site cost include \$681,087 for demoltion of the old high school building and major site work at the adjacent middle school.

Norrell Annex Elevator Addition (123-142-00-101) : Project is an elevator addition.

Virginia Heights Elementary Additions and Alterations (124-07-00-101) : Cost also include off-site construction of two classrooms.
